## **Reports:**

## Jadie Beam - SOAR Director, ESU 13 - State of Schools Report Card

Jadie gave a presentation to the Board on the State Report Card. Assessments are now being done on a multi-tier level so that scores are available throughout the year. Formative is Instructional Practices and Tools; Interim is MAP Growth and other measures and Summative is the annual measurement. Nebraska Student-Centered Assessment System (NSCAS) utilizes College and Career Ready testing rather than State Proficiency. The data from these reports help drive where the ESU SOAR staff goes to help students by pouring support into needs improvement districts. Currently, there are 7 buildings in our member district area that are on needs assessments.

The ACT is given in the 11<sup>th</sup> grade as the state assessment. It is funded by the State Department of Education for every junior. Last year, 86% of juniors had taken the ACT assessment so it was an easy transition moving to the state wide assessment. The ACT state average for ELA is 17.8 and math and science is 19.

#### AESA CONFERENCE-SAN ANTONIO, TX

Several Board Members and Dr. West attended the AESA annual conference in San Antonio on November 29-December 2, 2017. The theme of this conference centered on poverty. Some of the sessions attended were: Federal Lobbyist, Maker Movement in Education, Para-Educator training given by our ESU staff members, Increasing Engagement and Inspired Leadership, Liquid Gold for Leaders. Discussion of the content and several ideas were presented for ESU enhancement.

## <u>Administrator's report (Jeff West):</u>

- The Administrator reviewed with the Board that the concrete parking lots should be done at the end of this week. Bids are being sent out for the upcoming work on the metal siding and doors on the multi-purpose room. The Finance Committee will meet on the February Board meeting date to open bids. Bids are also being requested for the ESU 13 yearly audit and will also be opened at the February Board meeting date.
- We now have a bill being presented by Senator Stinner during this upcoming legislative session regarding our Day Treatment/Day School project. This will certainly bring awareness to the needs of our districts.
- Our strategic planning process will begin in late spring. This will be a 2 3 year process. Dr. Larry Dlugosh will be facilitating this planning process. We will begin with 25-30 people to make up the strategic planning team. We will be utilizing Board members, superintendents and principals for this team.
- ESU has a Board Policy committee that will begin reviewing Board policy and presenting revised and/or new policy to the Board for adoption.
- The Board was asked if they would like to add tipping at 15% in Board Policy or the personnel handbook. The tipping policy will be for staff when they travel. It is the consensus of the Board to add this to the personnel handbook.

#### **Donna Jenne-Head Start – Non-Federal Share Form**

Donna presented to the Board that their time can be counted as part of our non-federal share requirement to match 20% of the grant. There will be a notebook available at each Board meeting so the Board members can document how much time is spent reading Head Start specific material, Board meeting time spent on Head Start, and travel time.
