Reports:

High Plains Psychology Internship Consortium – Dr. Katie Carrizales:

The mission of the High Plains Psychology Internship Consortium is to prepare and retain psychologists who provide behavioral healthcare to diverse children, adolescents, and adults in rural and clinical settings.

Dr. Carrizales went on to explain the different aspects of this internship consortium including the collaboration effort among four agencies in eastern Colorado and western Nebraska to pool and share resources for the purpose of creating a high-quality internship that meets the unique clinical and workforce needs of rural Colorado and Nebraska. The primary training sites of High Plains PIC include Converge Day Treatment Center (Fort Morgan, CO), Educational Service Unit #13 (Scottsbluff, NE), and the University of Northern Colorado Department of School Psychology (Greeley, CO).

High Plains PIC offers interns a unique opportunity to advance their clinical training in rural and frontier settings, areas in which behavioral healthcare is often in short supply. Interns are afforded rich clinical experiences that highlight the specific demands and shared experiences within these small communities, as well as identify and creatively address the common barriers inherent in rural health. As providers, interns participate in High Plains PIC's goal to expand the capacity of underserved rural communities to address behavioral healthcare needs through integrated services. The major training emphases are: Behavioral Health Intervention, Psychological Assessment, Interdisciplinary Collaboration and Consultation, and Trauma-Informed Care.

One licensed psychologist serves as primary clinical supervisor for interns at each consortium site. Each intern will receive weekly individual supervision.
