Reports:

Nicole Johnson, ESU 13 Director of Early Childhood, gave a presentation that included a department overview of Head Start/Early Head Start, Early Development Network, Sixpence Sprouting Success, Rooted in Relationships and Panhandle Early Learning Connections. Partnerships and Coordination including membership in State Committees and Workgroups in addition to local partnerships and coordination were outlined. She informed the Board that ESU 13 is blazing a trail in coaching of child care programs by cross training coaches in multiple initiatives. Looking to the future, the ESU 13 Early Childhood Department will continue to support school districts, preschools, and childcare in filling the gaps of quality experiences available to children and families.
