# Public Forum - no items.

## Reports:

- <u>Abbie Winters of Winters Creative</u>: Abbie presented to the Board the Pre-Bid Summary of the ESU #13 signage package for the entire facility. She outlined the timeline for the project. There will be five types of signs: Pylon signs, Post and Panel Signs, Interior Wayfinding signs, Interior Room Identification Signs and misc. additional signs. Additionally, she referenced the map showing where the signs are going to be placed. The summary and map has been presented to the Directors, Maintenance and Technology. Jeff noted the colors of the signs: Blue, White and Gray. Board member Diemoz asked about "no gun" signs. This will be ordered separately and not from Abbie Winters. There were a few more questions regarding wording on the signs. These are noted and changed. Bids will begin next Friday. Opening of bids will be at the next Board meeting. Estimate for completion would be approximately 4 weeks.
- <u>Administrator's Report (Jeff West)</u>: Jeff again reviewed the Scottsbluff location facility projects which should begin in the Spring. He would like to start having the engineers begin the process for the parking lot now, however, it would be paid in the next fiscal year.

The agreement from Baker and Associates is on the agenda for review and approval. The only addition is the "garage additional heat and power".

He presented the need to replace our oldest mid-bus next year. It is estimated that the cost for the bus will be about \$65,000.

When the actual report from AdvancED comes, he will go into more detail with the Board. He shared that we are above the National Average score in Teaching and Learning Impact (ESU score 293.33, National Average score 267.91) and Leadership Capacity (ESU score 309.09, National Average score 292.76). We are below average only in one area which is the Resource Allocation (ESU score 283.33, National Average score 284.48).

We will be restructuring our Finance department due to some of the suggestions made by our auditor for better internal control. The Business Manager will allocate some of her AP duties to a part time person who will also be part time for the EDN department. She will be able to provide more oversight and monitoring in the department. The Finance committee agreed to update our monthly financial reporting. The check register report will be given each month for the Board members to see, then the budget report for those payments will be given the following month.

We will be purchasing a policy manual and yearly updates from Perry Law Firm. This manual will pertain to ESU policies.

- Legislative Issues Conference/Budget & Finance Workshop (Diemoz, Knapper): Bill Knapper and Steve Diemoz attended the meeting. The Governor did not attend which caused some tension. Bill attended the pre-session "Promoting Early Childhood" and the "Medicaid" session. Steve noted LB 65 which would allow state employees to volunteer as substitutes and mentors.
- <u>Education Forum (Millette)</u>: Tom attended several sessions at this conference including: John Cook – Dream Big Like a Champion, Career Pathways (students go there for 3 hours a day and earn dual credit hours). He attended Lion's Decatur which has community projects for students to complete from start to finish.
- <u>Head Start Policy Council Activity Report and Director's Report:</u> Nothing to add to the reports.

# Old Business:

Board policy regarding Weapons; Use of Metal Detectors; Searches, Seizures, and Arrests; Security; and Access to Buildings was presented as first reading with amendments. No action taken.

#### New Business:

Moved by Richards, seconded by Marx, that the Board ratify the proposed Negotiated Agreement between ESU #13 Board of Education and the ESU #13 Education Association. Questions were answered regarding horizontal placement and release from contract. Jeff approves all horizontal placement. Aye: Jones, Knapper, Millette, Sinner, Tollman, Diemoz, Dobry, Egging. Nay: None. Absent: Marsh. Motion passed.

Moved by Knapper, seconded by Sinner that the Board approve the change in reporting of the monthly financial summary. Aye: Marx, Millette, Richards, Tollman, Diemoz, Dobry, Egging, Jones. Nay: None. Absent: Marsh. Motion passed.

Moved by Millette, seconded by Diemoz that the Board approve that ESU #13 have only one audit in 2017 which will be the State audit in October 2017. Aye: Marx, Richards, Sinner, Tollman, Dobry, Egging, Jones, Knapper. Nay: none. Absent: Marsh. Motion passed.

Moved by Egging, seconded by Millette that Board approve the agreement by Baker & Associates outlining the projects, scope of work, scheduling, method of payment and amendment of agreement. Aye: Marx, Richards, Sinner, Tollman, Diemoz, Dobry, Jones, Knapper. Nay: None. Absent: Marsh. Motion passed.

Moved by Knapper seconded by Richards that the Board extend the ESU #13 Administrator's contract for an additional year to June 30, 2020. Aye: Millette, Sinner, Tollman, Diemoz, Dobry, Egging, Jones, Marx. Nay: None: Absent: Marsh. Motion passed.
