<u>Board Policy Committee report</u>: Patricia Jones presented a recommendation for changes to the policy for Expenses and Authorization for Attendance at Education Workshops, Conferences, Training Programs, Official Functions, Hearings, or Meetings. The Board discussed the amendments and the policy will be presented at the February meeting for adoption. The proposed Service Animals policy was introduced to the Board Members. The Board members discussed the proposed policy. The proposed policy will be sent to our attorney, Jerry Ostdiek, for review and presented as a first reading in February.

Administrator's report (Jeff West):

- At the next Board meeting, the Finance committee will meet prior to our regular Board meeting to open bids for metal siding/doors for the multipurpose room.
 They will also open bids for the 2017-2018 audit.
- Two new bills are being introduced by Senator Stinner that would impact ESU 13. LB801 (Day Treatment/Day School). There is no hearing date yet in the Education Committee. LB803 (NDE recertification bill) hearing is set for Monday, January 22, 2018.
- The State audit draft has been received. There is a 10 day window to respond with comments. Then, the State Auditors will publish the final report. We will provide the final report to the Board at the February meeting along with the exit report.
- Administrator evaluation tool examples were previously presented to the Board on September 19, 2017. After discussion, the Board will continue the same evaluation process this year and then review sample evaluations for the Administrator for next year.
- Our strategic planning process will begin in late spring. This will be a 2 3 year process. Dr. Larry Dlugosh will be facilitating this planning process. We will begin formalizing the list of 25-30 people to make up the strategic planning team. We will be utilizing Board members, superintendents and principals for this team.

 ESU has a Board Policy committee that will begin reviewing Board policy and presenting revised and/or new policy to the Board for adoption.
