## Reports:

Jadie Beam, ESU #13's SOAR department Director, presented AQuESTT EBA findings for member schools. She referenced the 2018-19 final classification report which revealed the breakdown of Excellent, Great, Good, and Needs Improvement. For our needs improvement schools, she and Dr. West, along with NDE, have contacted the schools to provide support for improvement. Plans have been set into motion for assistance in working together to improve the scores.

B.J. Peters, ESU #13's Technology Director, and member of our Safety Committee, reviewed with the Board that our Emergency Prevention and Response Plan was developed following guidelines from NDE and their increased emphasis on school safety. Lisa Myles, staff developer, helped design the "All Hazards" manual. Board members each received the manual in December. Staff at ESU #13 participated in two lockout/lockdown drills last semester in addition to the fire drills.

Head Start did not have a Policy Council meeting in December. Head Start Annual Report, Self-Assessment 2017-2018 and updated Five Year Goals were uploaded to Board website previously for Board review. No discussion.

Dr. Jeff West, Administrator, shared the following:

- The Sherwood Foundation application to help with funding for Panhandle Beginnings is still being completed.
- On-site sustainable replication of Boys Town Ecological In-Home Family Treatment Model is a future endeavor for our Behavioral Health department. The Juvenile Justice Home-Based Initiative is responsible for the request for qualification (RFQ) to address the needs of youth on probation in homes, schools and communities.

## OLD BUSINESS:

Proposed Defibrillator (AED) policy and protocol was presented as first reading. Policy Committee recommendation is noted for final reading. No action required.

Proposed revision of the Family and Medical Leave Board policy was presented as first reading with amendments. Discussion: continue legal counsel for further clarification. No action required.
