Reports:

Dr. Katie Carrizales, ESU #13's Behavior and Mental Health Director, gave a report on ESU #13's involvement in the Boy's Town Ecological In-Home Family Treatment. This program will serve moderate to high-risk youth and families that are involved in the juvenile justice and/or child welfare system by providing a 3 to 6 month intervention including parent and youth skill building, engagement, assessment, service planning, and cross agency dialogue. This program fits within our strategic goal of enhancing continuum of Behavior and Mental Health supports to our panhandle youth. After approval of our application, ESU #13 will initially employ 2 family consultants.

Jack Baker of Baker & Associates gave a report of the Agreement for the WNCC/ESU #13 Sidney campus construction.

Head Start Director, Donna Jenne, updated the Board on the Early Head Start program that moved to the WNCC building. This program serves 40 infant and toddlers. Preschool programs will be provided at new locations in the fall.

Administrator report:

Updates on construction: SOAR office remodel: change order received due to foundation issue. Additional concrete and foundation sealer needed.

Three employees from our Business Office will be attending work session in Sioux Falls focusing on entering the new account codes required by the state.

Administrator reviewed with the Board that he has been visiting with member school district administrators to listen and learn on how we can continue to provide support and services to their students.

Dr. Dick commended Laura Barrett on her years of service and leadership as SPED director at ESU #13. He also thanked her for her support during her role as interim administrator and during his transition to that position.
