- Discussion of ESU 13's internal and external surveys. We are continuing our effort to educate schools and stakeholders what services we offer. At the beginning of the 2018-2019 school year, some of our staff will be attending inservices at the schools to better communicate to staff about our services.
- Our Tech Department will be setting up email addresses for our Board members. The Network Acceptable Use and Internet Safety Policy will be emailed to them for review and signature before the ESU emails are set up.
- Pam Brezenski, Transition Coordinator, has been re-assigned for the 2018-2019 school year. She will be the SPED Coordinator. She is working towards her administrative degree which is required for the position.
- Horizontal Movement for teachers in the negotiated agreement was discussed. It is the consensus of the Board that the Negotiate Agreement only allows approval of classes that pertain to the certified staff's teaching assignment at ESU #13.
- We will continue to discuss and explore options for the possibility of piloting a day treatment/day school program.

- New Board Policy templates were distributed to the Board Policy subcommittee. These templates were provided by Perry Law Firm that pertain to ESUs and not school districts.
- We are still finalizing our safety plan for ESU 13. Directors have shared their suggested changes. Once the Directors and the ESU 13 Safety Committee approve the plan, it will be brought to the Board for review and approval.
