## Reports:

Jadie Beam, ESU 13 Director, Professional Learning, presented ESU 13 Schools AQuESTT EBA findings. The content of her presentation included:

- AQuESTT Tenets
- Comprehensive Support & Improvement (CSI)
- Priority Schools
- Targeted Support and Improvement (TSI and Additional (ATSI)

She explained the indicators for measuring gain in student achievement or element perceived to influence those gains. The indicators are: Status, Progress, Graduation Rate, Progress Toward English Language, Chronic Absenteeism and Evidence-Based Analysis. The board was given the 2019-2020 Final Classification report for ESU 13 districts.

Donna Jenne, Head Start Director, presented Head Start Program Governance Training with the Board Members. The Board viewed a power point focusing on:

- The Head Start Act of 2007 describes the composition and roles and responsibilities of Head Start agency governing bodies and Policy Councils with regard to program design, planning, monitoring, and oversight.
  - Works in conjunction with the Head Start Program Performance Standards, describes performance expectations regarding program governance.
- Board Members received a copy of the Head Start Program Governance Reference Book for their records.
- Board Members received a copy of the Head Start Program Philosophy for their records.
- Governing Body Reports were explained and will be reviewed monthly:

- Monthly financial statements including credit card expenditures
- Monthly program information summaries
- o Enrollment reports
- Monthly reports of meals provided through the Department of Agriculture (CACFP)
- Financial Audit reports
- Results from Federal Reviews and follow-up
- Annual self-assessment and results
- Strategic planning and needs assessments
- Communication and guidance from the Office of Head Start (OHS)
- Program Information Report (PIR)

Donna Jenne, Head Start Director, then spoke to the Board Members about the upcoming submission of the 2020-2021 Baseline Grant Application to be submitted by December 31<sup>st</sup>, 2019.

- Baseline application in the amount of \$3,160,157.00 is being prepared for submission to the Administration for Children and Families for Head Start and Early Head Start Programs.
- This grant includes the Head Start Five Year Goals, self-assessment results, T/TA plan and School Readiness plan.
- Input for the 2020-2021 baseline grant was addressed during the October 2019
  meeting and open discussion took place at the November 2019 meeting to
  review and ask for additional input. Discussions included the possibilities for
  increasing Home Base slots for families in Cheyenne and Kimball counties,
  increasing public school partnerships with Gering district, and addition of EHS
  infant/toddler center-base slots.

### Administrator's report:

The Substance Abuse and Mental Health Services Administration, Center for Mental Health Services is accepting applications for fiscal year 2020. ESU 13 will be submitting an application for the grant that could provide additional funding for the Day Treatment/Day School program.

To meet our strategic Objective 1.1, ESU 13 and 11 member schools are forming a consortium to contract with PowerSchool-TalentEd to provide online hiring and recruitment.

Board Comments: Patricia Jones asked how we serve nonpublic schools. According to Jadie Beam, ESU 13 Director of Professional Learning, we offer trainings at the same charge we offer our member districts. Board Member Heather Crofutt said that Chadron has a private school, Great Foundations.

President Sinner encouraged other Board members to find a date on their calendars to visit our ESU programs.

President Sinner reported there is an app for AESA and it shows the National Conference breakout sessions, etc.

Board member Ray Richards attended the community outreach program that LifeLink students along with their partner, WNCC. The skit/theatre production was focused on bullying and written by students.
