## **Reports:**

Danielle Cole, ESU 13's Title 1C Migrant Education Director, reported to the Board that the program's name has changed to Title 1C Migrant Education. She informed the Board that the program serves 650+ students in 41 school districts. They have 9 full time staff and many part time and summer staff. The qualifications for this program are migrant (mobility) children who are under 21 years old, have yet to graduate, moved across school district lines in the last 36 months and that the child, guardian, or financial support person works in agriculture. The program offers several supplemental services such as instruction, nutritional services and many more.

Kerry Mehling, Assistant Director of the Head Start Program, reviewed that the program serves 248 preschool children ages 3-5, and 68 infant and toddlers for a total of 316 children. The Head Start program currently has 6 public school partnerships. She explained the new 5 year grant application process with the Board. Future possibilities include offering home services, more public school partnerships and having full day programs. The Board was asked for input on the grant submission.

Head Start Director's Report and Policy Council Minutes for September – No discussion.

Dr. Dick gave the Board an update of his attendance at the LR 63 hearing. All 17 ESU Administrators were there as well as 25-30 other ESU supporters.

The Non-certificated/Classified Evaluation instrument is being revised. He will present the final draft to the Board in November.

Project Discovery – Dr. Pam Brezenski, Special Services Director, coordinated this project and was informed that it is receiving federal recognition. This project focused on employment for youth with moderate to significant disabilities. Our Meridian students completed the curriculum and were successful in employment.
