# **Reports:**

Head Start Director Reports and Policy Council Meeting Minutes were uploaded for Board review-no discussion.

Board member reports: Several Board members attended the NASB Area membership meeting held August 28<sup>th</sup> in Gering. The break-out sessions attended included topics such as keeping students and staff safe at school, overview of ESSA, AquESST and School Improvement, and delegate assembly. Mr. Knapper attended the Labor Relations Conference for updates in negotiations. He reviewed the timeline for negotiations. ESU #13 will be participating in negotiations this year for the 2019-2020 school year.

### Administrator Report:

- Facility updates: Proposed projects include bus and vehicle garage, front drive concrete and landscape project at Scottsbluff site. Sites for the Sidney ESU are still being explored.
- Membership in NRCSA was discussed. The Board declines at this time.
- A facility site plan for our pilot project, New Beginnings Day Treatment and two other programs is still being studied. The Building and Grounds committee will tour possible locations for this project with an architect to obtain a rough budget cost. There is no cost for this initial review of the building.
- Hire dates for compensation increases for classified staff were discussed. We will get a legal opinion regarding this matter. It will then be posted to the Personnel Handbook.
- As we expand our services, office space for additional staff is becoming scarce. Dr. West proposed to the Board renting some office space at the UNL building. The Board gave Dr. West the authority to rent additional office space at other locations as the need arises.

### **OLD BUSINESS:**

Proposed Board policy regarding Records Management – Email Retention, Disposition and Litigation Holds presented as first reading. No action taken.
