E. New Business

1. <u>Public Hearing to Amend the Proposed Redistricting Plan and Motion to</u> <u>Adopt the Redistricting Resolution</u>

According to § 79-1217.01 - By December 31, 2007, and after each decennial, each educational service unit board shall divide the territory of the educational service unit into at least five and up to twelve numbered districts for the purpose of electing members to the board. Such districts shall be compact and contiguous and substantially equal in population. Utilizing the 2020 Census of Population data, the Election Districts Committee has been working with Susan Myers from M.C. Schaff to draw the district boundaries. Redistricting Resolution can be found on <u>Appendix B</u>. The election district county breakdown can be found on <u>Appendix</u> <u>C</u>. The exhibits have been uploaded to the Board Materials webpage. <u>Recommendation</u>: Move to adopt the Redistricting Resolution and authorize the Interim Administrator to submit this Resolution with attachments to the county clerk or election commissioner by December 30,

2021.

2. Interim Administrator Contract

The Personnel Committee met prior to the November 9th Board meeting. The Committee is recommending the appointment of Dr. Laura Barrett to Administrator and to allow the Board President to negotiate a contract. The contract will be brought to the Board at the January 2022 regular meeting. Recommendation: Move to approve the Personnel Committee's recommendation to appoint Dr. Laura Barrett as Administrator and allow the Board President to negotiate the contract.

3. <u>Amendment of Board Policy - Article 4, Section 13 (Travel Policy)</u>

Consent action item, Staff Travel, was discussed at the November Board meeting. Further investigation into §13-2203 allows for prior approval for participation or attendance at educational workshops, conferences, training programs, official functions, hearings, or meetings by the formal adoption of a uniform policy or by a formal vote of the governing body. We have amended our Board Travel Policy to allow the Administrator to approve such travel (uploaded to Board Member webpage). The Policy Committee received the proposed amendment on December 6th.

<u>Recommendation</u>: Move to approve the amendment to Board Policy - Article 4, Section 13 (Travel Policy).

4. <u>Revision and Updated Head Start Policies and Procedures</u>

As per the Performance Standards, we need Board approval of revised Policy and Procedures. The Head Start Program Governance Written Plans PG01-PG20 have been uploaded to the Board material webpage. The Policy Council approved the Program Governance Written Plans at their meeting on November 30, 2021.

<u>Recommendation</u>: Move to approve the Head Start Program Governance Written Plans.

5. Head Start/Early Head Start 2022-2023 Continuation Grant Application

The 2022-2023 Continuation Grant in the amount of \$3,313,210.00 will be submitted on or before December 31, 2021 to the Administration for Children and Families for the Head Start and Early Head Start Programs. The program plans to serve a total of 286 children (202 Head Start and 84 Early Head Start). There are 148 of the Head Start Children that will be served in public school partnerships including Tri-Community Preschool in Morrill, Mitchell Tiger Cub Preschool, Scottsbluff Bear Cub Preschool, Gering Public Preschool, Minatare Pre-Start, Bayard Tiger Cub Preschool, and Sidney Public Preschool. The program intends to reapply for the LDO - Class Size Waiver as part of the grant application to allow for partnership school districts to serve up to 20 children in each session for double session classrooms. The program's progress toward five year goals, program annual community assessment surveys, parent surveys, and staff surveys have been guiding factors in writing the continuation grant without any proposed service changes at this time.

<u>Recommendation</u>: Move to approve the 2022-2023 Continuation Grant application for the Head Start/Early Head Start program in the amount of \$3,313,210.00.

6. <u>HVAC Project for Second Level, Main Building and Surge Protection</u> Prior to this meeting, the Building/Grounds Committee met with Baker & Associates regarding the timeline for the HVAC system for the 2nd level building as well as improvements for surge and lighting protection for the entire building. <u>Recommendation</u>: Move to approve the Building/Grounds Committee recommendation for Baker & Associates to begin the process of requesting

REDISTRICTING RESOLUTION

WHEREAS, Neb. Rev. Stat. § 79-1217.01 requires each educational service unit (ESU) divide its territory into at least five and up to twelve numbered districts after each decennial census for the purpose of electing members to the board in compliance with section Neb. Rev. Stat. § 32-553; and

WHEREAS, Neb. Rev. Stat. § 32-553(2) requires the ESU governing board to draw its own district boundaries and requires the board to follow the precinct lines created by the election commissioner or county clerk after each federal decennial census as nearly as possible; and

WHEREAS, the numbered districts must be compact, contiguous, and substantially equal in population; and

WHEREAS, the results of the 2020 decennial census must be reviewed and considered; and

WHEREAS, during the redistricting process the ESU provided notice to the public regarding ESU #13 election districts in compliance with the Nebraska Open Meetings Act;

WHEREAS, the ESU Board considered the proposed redistricting plan at a board meeting and has considered any testimony, written comments, written reports received;

WHEREAS, the ESU Board finds the proposed redistricting plan to be in the best interest of its patrons and believes that it complies with all state and federal laws and requirements;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED AS FOLLOWS:

1.) The Educational Service Unit No. 13 district boundaries are as shown on the map(s) as Exhibit A and as may be further described in the document(s) as Exhibit B and adopted to define ESU No. 13's district boundaries. Exhibits A and B will be incorporated herein and made a part of this Resolution.

2.) The ESU No. 13 Administrator is authorized and directed to submit this Resolution with the attachments to the election commissioner or county clerk.

3.) The established districts shall apply beginning with the nomination and election of educational service unit board members in 2022.
