Administrator Notes February 2023

Northern Student Program Discussion

We had limited interest in the student programs expansion to the northern tier and will not be able to fund programs starting up for the 2023-24 school year. The directors will be reaching out to the districts to assist in designing support for the students that they were hoping to provide a Meridian or VALTS program.

Stakeholder Surveys

On February 17th we closed our annual stakeholder survey. This was sent to all staff both internally and in our schools. This information will be reviewed at our March 17th inservice day with our staff and a summary will be shared with the board at our April meeting.

Vehicles

To keep current on our vehicle rotation and replacement schedule, we will need to look at purchasing 2 vehicles to add to our fleet this year. I will be working on gathering bids for vehicles and will ask the Finance & Budget committee to review those prior to the March meeting.

Midwinter Conference

The mid-winter conference was held on February 20th. This was our 36th annual conference and we had 35 sessions, 5 in person locations and some on zoom. We had over 1,300 professionals registered.

Defining Success at ESU 13

As a part of our strategic plan, we are working on organizational effectiveness. One of our steps in that plan is defining success for ESU 13. Our strategic planning group would like to gather information from the ESU 13 Board on what you see as success for our organization. EDUCATIONAL SERVICE UNIT NO 13 PROPOSED CONTRACT EXTENSION AND SALARY AGREEMENT (Extension through 2025-2026)

The Board of Educational Service Unit 13 (ESU 13) and Dr. Laura Barrett agree to the following addendum to the Administrator's Contract of Employment entered into between the Board and the Administrator on January 18th, 2022.

- 1. **Extension of Contract**: The Contract is extended for an additional two-year term, such that the term of the Contract is for a three-year term beginning on July 1, 2023 and terminating on June 30, 2026.
- 2. Salary: The annual base salary for the 2023-2024 year shall be \$180,000.
